## DIRECTIONS

**Pad/Bonnet Cleaning:** Dilute 64 ml of PERFECT per litre of hot water (8 oz/gal) (1:16).

**Traffic Lane Pre-Spray:** Dilute 45 - 80 ml of PERFECT per litre of hot water (6-10 oz/gal) (1:21 - 1:13).

**Extraction:** Dilute 8 - 30 ml of PERFECT per litre of hot water (1-4 oz/gal) (1:128 - 1:32).

**Spot and Stain Removal:** Dilute 80 ml of PERFECT per litre of hot water (10 oz/gal) (1:13) or use undiluted for tough stains and gum.

**Upholstery Cleaning:**

**Light soil:** Dilute 8 ml of PERFECT per litre of hot water (1 oz/gal) (1:128).

**Heavy soil:** Mix 30-45 ml of PERFECT per litre of hot water (4-6 oz/gal) (1:32 - 1:21).

**NOTE:** Before application, pretest for colorfastness in an inconspicuous area.
